  - Is open only between the hours of 10:00 a.m. and 8:00 p.m.;
  - Complies with the site requirements of LAMC § 45.19.6.3.L and O;
  - Complies with operational requirements of LAMC § 45.19.6.3 H, J, K and M;
  - Has identified the MMC managers to the City Clerk and had its managers complete Livescans, pursuant to LAMC § 45.19.6.3.M, annually since 2013;
  - Has managers who are compliant with LAMC § 45.19.6.3.M.

5. **I understand that this Tax Registration Certificate is not a license to operate an MMC and its issuance does not indicate compliance with LAMC Section 45.19.6/Proposition D.**
6. **I understand that the MMC's Business Tax renewal and payment will not be accepted unless a fully completed and signed affidavit is submitted to the Office of Finance.**
