#### INSTRUCTIONS FOR FILING OF APPLICATION FOR VOLUNTARY DISCLOSURE

An application must be completed and signed under penalty of perjury in order to participate in the Voluntary Disclosure Program. To remain anonymous, if so desired, an applicant may have an authorized representative contact the City. The representative should not reveal the name of the applicant or any information that could readily identify the applicant to the Office of Finance until the agreement is executed.

## **Application PART I**

If the applicant does not wish to apply anonymously, the applicant must enter its legal business name, business address, primary contact person, title, and telephone number.

If the applicant wishes to apply anonymously, please enter the name, title, address, and the telephone number of the applicant's authorized representative. The applicant must authorize the named individual to serve as the applicant's representative during the Voluntary Disclosure Program application review process.

#### **Application PART III**
